6.	The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary General within seven days of the issuance of the voters' list.	24 July (Friday)

8.	Intimation of action on the objections by the Secretary General within five days from receipt of objections.	29 July (Wednesday)
9.	Person aggrieved by the decision of the Secretary General may make a representation, within three working days.	1 August (Saturday)

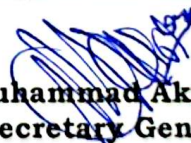

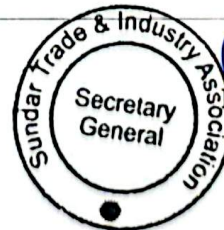
